## **Group Leader Supervision Responsibilities**



# Recovery Games 2025

All of the team at The Recovery Games work together with visiting group leaders to ensure a consistently safe environment. With that in mind please see the group leader's responsibilities below.

- Throughout the entire day the group leader will be in loco-parentis of every child.
  - They will have the right to remove a child at any time from any activity if they deem necessary.
- During an activity session authority of the group transfers to the Recovery
  Games member of staff. That member of staff reserves the right to exclude
  any individual or curtail the activity session for safety reasons.
- We encourage group leaders and supporting staff to engage with their groups during activity times. Although we do not insist on a staff member being present at each activity base, their location on site must be made known to the management team should the need arise for their immediate attendance.
- There must always be a nominated supervising adult responsible for the group on site.
- First aid provision on site is provided by an appointed staff team during staffed hours. The group leader will decide if an individual requires additional medical support. Outside of staffed hours it is the responsibility

- of the group leader to ensure sufficient first aid provision is in place for the nature and size of their group.
- Should a group member require additional medical support the group leader should make arrangements to contact the parent/guardian of the individual, in order to do this effectively the party leader must hold a copy of emergency contact details for every group member.
- Recovery Games staff cannot administer any form of medication; this is the responsibility of the group leader or trained medical staff on site.
- It is the group leader's responsibility to ensure that all participants are at each event in a timely manner. The group leader will be provided with a pack that will include a number of programmes along with a map of the site pointing out each event area as well as a timetable of where and what time to be expected at each event. Failure to arrive within that time frame may result in your team forfeiting that round. This will be at the discretion of each event marshal.
- There will be photography and filming of the event throughout the whole day and it is the group leaders responsibility to identify and inform any members of their group of this and to make themselves known to the camera crew if they don't wish to be filmed. As much as it is their own individual responsibility to be mindful as to where filming may be taking place.
